

Ethics can be mind numbingly dry material and more then a littel confusing at times. This text does a good job of laying out the important aspects of this area and reminds the reader that certain things vary from state to state. It's pretty comprehensive and gets the job done without putting you to

I downloaded this book for an ethics class. It was a quick and easy download into my Kindle app on my laptop. The authors made the intimidating topic of ethics and legal issue in counseling easy to understand and apply to the case studies provided during my course. The authors provide many examples and scenarios of how each topic covered in counseling ethics, which made the information easy to process.

I love being able to breeze through the text and the convenience of carrying the book on my tablet. The one drawback is the lack of page numbers for referencing. Might have to get a little more familiar with operating the icons.

Book was a little more worn than I thought- additional charge for expedited shipping was more than expected but since it would not give me a total until after completed the order it was too late to change it.

Although I received my book in a timely manner, there was heavy wear and tear on the book. The previous owner did a lot of highlighting and writing in the margins of the book which makes it difficult to read. In the description of the condition of the book it never stated how much it had been used. Highly disappointed.

I am reading this book for school of course - certainly NOT for pleasure. It's less than exciting, but more due to the topic at hand, than the material. What I have noticed, however is the abundance of typos throughout the book. I have never seen so many errors in a text book in my life - kind of funny really. I guess they need to get a new proofreader for the next edition. In Ch. 3 alone I've found 4-5 words already -and I'm not even done w/the chapter yet.
