

All the main cyclostratigraphic methods are covered, including spectral analysis, cross-spectral analysis, filtering, complex demodulation, and wavelet and singular spectrum analysis. Practical problems of time-series analysis are considered in detail. Recent research into various types of tidal and climatic cycles is summarized.

The qualitative descriptions of time-series analysis were helpful to me in that I know have a basic understanding of how time-series analysis works. The book was written for serious math-phobes, so if you never want to see an equation but need to understand time series analysis, this is the book for you. I'm not quite that math-phobic, so for me the book would have been more helpful had the math behind the analysis been included somewhere, even if just as an appendix.
