Using Styles

A style is a named group of format that can be applied and changed in one step in selected text and tables. You can:

- Apply consistent formatting to text.
- Select all text with the same style.
- Change the formatting of all text with the same style.
- Create a table of contents based on the default heading styles that have been assigned to text.
- Use the same pre-existing style to create a new format for text.

Character, Paragraph, Linked Styles

Character style: Use to consistently apply text formatting to text.

Paragraph style: Use to consistently apply text and paragraph formatting to paragraphs.

Linked style: Character and/or paragraph style applied to text.

Applying Character and Paragraph Styles

- Select the text or paragraph that you wish to apply the style to.
- Click the style in the Styles task pane, or click the style in the Styles gallery.
- Click the style in the Styles task pane, or click the style in the Styles gallery.

Creating a Style

- Select the text or paragraph that you wish to apply the style to.
- In the HOME ribbon, click the NEW STYLE button.
- Click the style name in the style list.
- Click the style name in the style list.

Displaying the Styles Pane

Click the HOME ribbon, click the NEW STYLE button.

Deleting a Style

- In the STYLES group, click the DELETE button.
- Click the style name in the style list.

Selecting All Text with the Same Style

- In the Quick Style gallery or STYLES pane, click the style you wish to apply.
- Click the style name in the style list.

Showing Formatting as Styles to Clean Up a Document

- In the STYLES group, click the SHOW button.
- Click the style name in the style list.

Importing Styles from Another Document

- Click the HOME ribbon, click the IMPORT button.
- Click the style name in the style list.

Using Numbered Lists with Styles

- In the HOME ribbon, click the NUMBERING button.
- Click the style name in the style list.

Restricting Formatting

- Click the HOME ribbon, click the RESTRICT button.
- Click the style name in the style list.

Creating a Table of Contents

- Click the HOME ribbon, click the TABLE OF CONTENTS button.
- Click the style name in the style list.

Updating a Table of Contents

- Click the HOME ribbon, click the UPDATE button.
- Click the style name in the style list.

Preparing an Index

- Click the HOME ribbon, click the INDEX button.
- Click the style name in the style list.

Generating an Index

- Click the HOME ribbon, click the INDEX button.
- Click the style name in the style list.

Easy to read sheets in nice heavy lamination. I used a three hole punch and inserted them into a three ring binder to make a handy reference guide that won't tear, wrinkle or be ruined if I spill coffee on it!!

Carry this and other reference cards with me to work in my briefcase. They are very helpful to those who are familiar with the program but occasionally need a command reminder. I have these reference guides for all programs I deal with.
