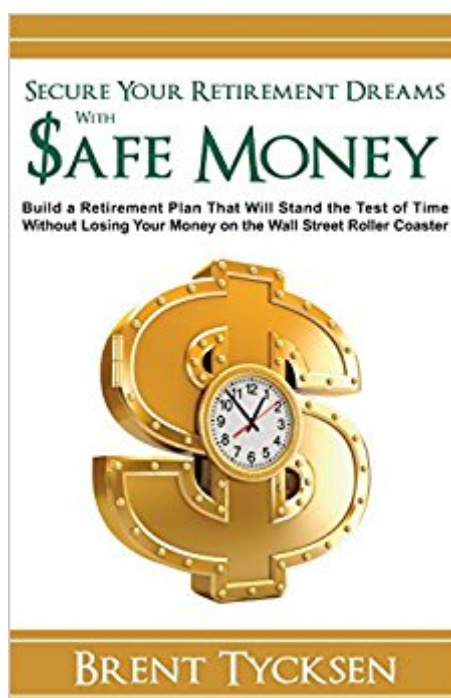

A must read if you want to take charge of and control your retirement. I am in the insurance industry

and this is a great strategy to use as part of your retirement. When most people lost up to 50% of their retirement in the market my clients didn't lose a dime as they were in a properly structured life insurance policy that: doesn't have high fees, they have access to anytime without penalties, grows tax free, takes advantage of market gains but none of the losses, they can take THEIR money out without paying taxes on it, all while providing a TAX FREE death benefit for their loved ones. You'll never lose money as long as you don't let the policy lapse. It's crazy. There are a lot of "experts with opinions, but none of the facts." Get the facts, read this book. "Tax Free Retirement" is another good book to read.

I'm not one to leave reviews typically, but I will say the strategy discussed in this book, if properly structured and funded, is unbeatable. It's not my favorite book on the topic, but it gets the point across. The top 1% wealthy in the country have 55% of the Life Insurance Retirement Plan Assets referred to in this book (see WSJ article below). I always figure if you want be wealthy that it would make sense to do some of the things the wealthy do. I am in the financial industry and offer mutual funds, 401k, IRA, insurance, etc. The LIRP strategy is by far the most popular with my clients because ultimately the numbers don't lie (but the big wigs and talking heads of the industry do unfortunately). I would recommend finding someone who knows how to properly set these up and have a conversation with them.

This must be some kind of insurance sales scam. It is the exact same book as "Safe Money Millionaire" by authors Brett Kitchen and Ethan Kap. The personal stories are different but the

content copy is identical. All authors are taking credit for their "research" so who's plagiarizing?

I was referred to this kind of book from a radio program that generally made the same claims to tax-free retirement planning. It's not immediately obvious, but this is insurance as an investment, where you pay tax upfront on your deposit and draw upon it later. The issue with these products appear to be the management fees, high ongoing payments and penalties for early withdrawal. Not sure this makes sense as a primary retirement planning strategy - maybe if you had already maxed out 401K etc, perhaps. The anecdotes about various famous personalities who drew upon their insurance policies to build massively successful businesses are all very well, but not too appropriate to the audience. It's attractive to claim "tax-free" investment, but it would be more transparent to simply explain that the tax is paid up-front (although it might end up being much less, assuming you stayed with the insurance payments, etc).
